Dear Participant,

You are invited to participate in the research project described below.

### **What is the project about?**

This research project is about dental habits, general health, and early childhood development relate to outcomes in children and young adults in Australia. We want to examine a range of potential influences, including demographics, environmental factors, and the different ways families manage their children's health. The focus of the present study is on dental health and dental care and how it relates to the cognitive development of children and young adults in Australia.

### **Who is undertaking the project?**

This project is being conducted by an international research team led by Professor Loc Do, a dental researcher at the University of Queensland. The team includes Dr Alyssa Sawyer, a psychological researcher at the University of Adelaide, dental researchers Dr Diep Ha at the University of Queensland and Emeritus Professor John Spencer at the University of Adelaide, Professor Alison Jones, a health expert at the University of Wollongong and the Telethon Institute, and Dr Sam Leary, a statistician at the University of Bristol, UK.

The project has received funding from the National Health and Medical Research Council.

### **Why am I being invited to participate?**

You and your child participated in the National Child Oral Health Study (NCOHS) 2012-14 and at that time you agreed for us to re-contact you for future research purposes. You and your family may have also participated in the first phase of our new study, 'Tooth for Health' in 2019-20. Participation involved the completion of a questionnaire about your child's dental and general health, and behaviours.

### **What am I being invited to do?**

You are being invited to participate in the second phase of our 'Tooth for Health' Study. Participation involves completing a short questionnaire in your own time. The questionnaire asks some demographic (e.g., age, gender) and basic health information about you and your child. You can choose to complete the questionnaire online or on paper.

Participation also involves your child taking a standard test of intelligence (IQ test) with a trained psychologist. The test will be an age-appropriate Wechsler Intelligence Scale that will involve a series of interactive tasks such as working with blocks or looking at patterns. The IQ test will be given using a traditional face-to-face format. We may request your permission to video record the session. This recording will be assessed by a senior psychologist and is for quality assurance purposes. The test will not be used as a diagnostic test. However, if necessary, the senior psychologist will discuss with you about further clinical assessment of your child by your own healthcare providers.

### **How much time will my involvement in the project take?**

Completion of the questionnaire can take between 5-10 minutes. Completing the IQ test can take between 60-90 minutes. In appreciation and recognition of your time and contribution, all participants will receive a \$30 Coles/Myer gift card and a dental care pack.

### **Are there any risks associated with participating in this project?**

No risk is expected from participating in this project. Some people may feel anxious about the intelligence test. Should you or your child experience any anxiety or distress, please do not hesitate to contact the principal investigator, who will address any questions or concerns you may have (details below).

**What are the potential benefits of the research project?**

While there may not be direct benefit to you or your child from participating in this project, its findings will provide valuable information to better understand links between the dental and general health of children and young adults in Australia. Such information will be important to advise the policymakers, dental care providers, and the community about important factors affecting health.

You will be provided a one-page summary of the IQ test results. You may also request that one of our senior psychologists contacts you for a feedback session if you would like to discuss the results.

**Can I withdraw from the project?**

Participation in this project is completely voluntary. Your right to decline will be respected and this will not affect your dental care or health services in any way. You may also withdraw from the Study at any time by contacting the researchers.

**What will happen to my information?**

The personal information that you provide are accessible only to the named investigators of this project. Your information will be de-identified and stored in the secure network of the University of Queensland and accessible only to the named investigators.

We will analyse the collected information to explore the possible associations with dental health for children and young adults. We will publish the findings in relevant scientific journals. The study findings will be reported in combined forms. Personal details including residential locality, age, and gender that may enable reidentification of a person will not be published. Your information will only be used as described in this Participant Information Sheet and it will only be disclosed according to the consent provided, except as required by law.
